### VOTE BY MAIL

Voting by mail is easy! Call the Elections Office at **863.993.4871** or click the Vote-By-Mail button on our website ([www.votedesoto.com](http://www.votedesoto.com)) to request a Vote-By-Mail ballot.

Vote-By-Mail ballots are **NOT** forwarded by the U.S. Postal Service. It is the voter's responsibility to provide an accurate mailing address. Ballots can be mailed worldwide.

### VOTE EARLY

**August 8<sup>th</sup> – 20<sup>th</sup>**  
**Monday – Friday 8:00 AM – 4:30 PM**  
**Weekends 7:00 AM – 3:00 PM**

Any registered and eligible voter in the county may vote early. Early voting is held in DeSoto County Supervisor of Elections Office at 201 E. Oak Street, Ste 104, Arcadia FL.

### VOTE ELECTION DAY

### THE AUGUST 23<sup>RD</sup> ELECTION IS A CLOSED PRIMARY ELECTION

- Democrats vote on a Democratic ballot.
- Republicans vote on a Republican ballot.
- Any other registered voter may vote a non-partisan ballot.

**Any voter who wishes to change party affiliation in regard to participation in this election must do so no later than 5 PM on July 25<sup>th</sup>.**

### *Has Your Signature Changed?*

Signature Updates can be made any time! A voter's signature on file is used to verify Vote-By-Mail (Absentee) ballots and petitions for candidates or initiative issues. If you believe your signature has changed, please send us an updated voter registration application. Print, complete and mail us a completed voter registration application form to PO Box 89, Arcadia, FL 34265.
