State and local governments shall retain their abilities to protect consumer rights and public health, safety and welfare, and to insure that consumers who do not choose to install solar are not required to subsidize the costs of backup power and electric grid access to those who do.</p>	<p>Proposing an amendment to the State Constitution to authorize a first responder, who is totally and permanently disabled as a result of injuries sustained in the line of duty, to receive relief from ad valorem taxes assessed on homestead property, if authorized by general law. If approved by voters, the amendment takes effect January 1, 2017.</p>

The amendment takes effect January 1, 2017, and applies retroactively to exemptions granted before January 1, 2017.</p>

Goodman <input checked="" type="radio"/> Judy Kirkpatrick</p>	<p>Allows medical use of marijuana for individuals with debilitating medical conditions as determined by a licensed Florida physician. Allows caregivers to assist patients' medical use of marijuana. The Department of Health shall register and regulate centers that produce and distribute marijuana for medical purposes and shall issue identification cards to patients and caregivers. Applies only to Florida law. Does not immunize violations of federal law or any non-medical use, possession or production of marijuana.</p>	<p><input type="radio"/> YES <input type="radio"/> NO</p>
	<p>Increased costs from this amendment to state and local governments cannot be determined. There will be additional regulatory costs and enforcement activities associated with the production, sale, use and possession of medical marijuana. Fees may offset some of the regulatory costs. Sales tax will likely apply to most purchases, resulting in a substantial increase in state and local government revenues that cannot be determined precisely.
